ELECTION OF OFFICERS AND DIRECTORS

It is time once again to be thinking about the annual election. If you are considering running for a position Criteria is as follows:

Candidates for officers and directors are required to have been a member of an Association for at least (2) years and to have served on a standing committee.

Criteria for President-Elect Nominees.

The nominee shall be a REALTOR® with at least three (3) years membership in the Board and shall have successfully completed service to the Board as:

- A committee member
- A chairperson of a committee

A three-year term as a Director, and/or Secretary, and/or treasurer.

All candidates are required to fill out a Election Application to be eligible to run for election.

The Election Application is available on the website.....mybcar.com. You must log in and go under association documents and click on other documents or call BCAR at 724-774-4126 to get a application.

The election slate will be presented to the Board of Directors at the August 18th Board of Directors meeting. Applications must be in before August 9th to the Nominating Committee. After August 18th petitions will be required.

BCAR's website is www.mybcar.com. After the header on the right hand side is a button to click to REALTOR in the two white boxes you use your real estate license number as your Username and password. Be sure to use capital letters. Once on the site then you can change your username and password. Be sure to click update member at the bottom of page to save changes. Also you can put in a personal bio and download your picture.
